


NINDS/NICHD-NCMRR NeuroRehab CDE Project Emotion Behavior Neuropsychology Subgroup Summary

The Emotion, Behavior, and Neuropsychology subgroup used a combination of the Diagnostic and Statistical Manual of Mental Disorders (DSM) (American Psychiatric Association, 2013) definition of emotional and behavioral symptoms and expert opinion from our subgroup members to define emotional and behavioral symptoms and conditions to be included in our review of measures. Per the DSM, the American Psychiatric Association (APA), defines emotional and behavioral symptoms as including depression, anxiety, agitation, irritability, impulsivity, aggression and violence, acting out, noncompliance, social inappropriateness, emotional outbursts, childish behavior, impaired self-control and self-awareness, drug/alcohol misuse, apathy, paranoia, confusion, frustration, sleep problems, and mood swings. Several concepts outlined by the APA (i.e., sleep problems, confusion) were covered by other subgroups and not included in our subdomain, and several concepts in our subdomain were identified to have likely overlap with other subgroups (see figure below). Our subgroup members also added the following domains, to cover additional behavioral symptoms, diagnoses, and positive emotional constructs: emotional lability, disinhibition, hopelessness, resilience, self-esteem, self-confidence, self-efficacy, positive affect, suicide risk, loneliness, somatization, psychosis, post-traumatic stress, mania, risk for hurting self or others, and impaired self-awareness.

The figure to the right represents the domains covered by our subgroup. Of note, some symptoms overlapped with other subgroups (the figure does not represent how those other subgroups may or may not overlap with each other).





Summary of Recommendations

The instruments in Table 1, organized by symptoms/conditions of interest, are **Supplemental – Highly Recommended**

Measures selected to assess change in emotional and behavioral functioning over time would be different across intervention, natural course/history, and disease progression studies.

This subgroup's focus was solely on adult emotional and behavioral functioning.


There are no formal neurorehabilitation standards established to which the CDEs can be compared.

Patient orientation and cognition should be considered prior to measure administration. In cases where patients' orientation or cognition would be expected to interfere with administration, proxy administration should be considered, when appropriate (based on the properties of the measure).

Gap Areas

The gap areas recognized in this initial NeuroRehab CDE project (i.e., need for potential new instruments) will provide a framework for identifying a continuum of CDE development activities needing to be addressed in upcoming annual reviews. Of all the domains identified by our subgroup, Depression, Anxiety, Apathy, Alcohol/Drug misuse, and Post-traumatic stress (PTSD) had the largest number of well-validated measures from which to choose. However, highly recommended supplemental measures were available to also measure irritability, impulsivity, disinhibition, emotional lability, impaired self-control, self-efficacy, positive affect, anger/aggression, loneliness, mania, psychosis, and suicide risk. Notable gap areas (i.e., domains not covered by any recommended measures) were: agitation, noncompliance, paranoia, frustration, mood swings, hopelessness, resilience, self-esteem, self-confidence, social inappropriateness, childish behavior, impaired self-awareness, somatization, and self-harm or risk of harming others. Our subgroup further recommends that some of the Supplemental – Highly Recommended instruments be updated to reflect further validation.





The following measures were recommended by the Emotion, Behavior, and Neuropsychology subgroup as potential measures for future inclusion as CDEs:

- Behavioral Rating Inventory of Executive Function (Brief-SR) self reported for adults: self-control (emotional control)
- Behavioral Assessment Screening Tool (BAST): substance abuse, negative affect, social executive function, impulsivity
- Beck Hopelessness Scale (BHS): hopelessness
- Personality Assessment Inventory (PAI): personality, emotional regulation, behavioral regulation, and underlying mood and anxiety disorders
- The Brief Symptom Inventory (BSI): somatization
- Symptom Catastrophizing Scale (Moore 2018): catastrophizing
